**Describe why you are selecting Comprehensive Learning as the school's Instructional Model for the effective dates of this plan**

Per Governor Kate Brown's metrics for school reopening order, our county and state do not currently meet those required aspects metrics. The TLC serves students with mental diagnosis of anxiety, PTSD, and ODD which could create challenges for students to maintain wearing masks. Additionally, students in the TLC program have significant behavioral issue regarding aggression and safety concerns and safety concerns toward self and/or running behaviors which frequently requires re-direction/restraint which cannot at this time be completed while maintaining the social distancing of the required 3-6 feet.

The TLC program will incorporate multiple modalities of learning both asynchronous and synchronous. Every student will have access to Chrome Books. Parents will be provided with a jet pack if needed to support their internet needs. Through the Chromebooks they will be able to access online academic program, TEAMS, and Canvas. The students will receive daily lessons with direct instruction virtually through TEAMS. Each lesson will be individualized to meet the needs of every student at their learning level. This includes students on IEP's. They will have their goals met through the daily lessons. All annual and re-eval deadlines will be met based off the dates on the students IEP's. Each student will engage weekly, in-person, with a community mental health provider and skills trainer so they can continue their support for their social emotional needs. Every teacher's classroom phone has been set up so when a parent/student calls it, the call goes to the teacher's cell phone. Parents/students can call the teacher any time during the set school day. Attendance is taken daily and participation will be tracked and recorded. A parent orientation well be held using social distancing in the classroom for

individual parent coaching sessions on technology use and an open Q & A forum.

The TLC program will re-evaluate will conditions according to the Governor's metrics to see discern if it can move to a hybrid model on a monthly basis. The predicted date if it does move to a hybrid model will be November 2<sup>nd</sup>. The decision will be made based on the guide lines of current ODE and OHA health recommendations in accordance with the Governor's metrics.

The responsibility of taking attendance must be performed by the teacher of record, not another staff member (e.g., the registrar or school secretary).
- Part-time students receiving online and/or hybrid instruction (not college courses):** Students who are not enrolled full-time and are taking online and/or hybrid courses offered by the school district or charter school are reported as large group instruction (program type 4), unless they are an ESD-registered homeschooled or private school student receiving supplemental coursework in public school, which are reported as shared time (program type 9). The district may count up to one hour per day per course taken, provided appropriately licensed teachers for the coursework taken, are available and accessible to the student during regular business hours on each school day to be claimed.
